VACATION ORDINANCE 2003-1151
(ORS 271.050)

**AN ORDINANCE CONCERNING THE VACATION OF A PORTION OF PUBLIC
RIGHT-OF-WAY OF MEINECKE ROAD CONSISTENT WITH CHAPTER 271 OF
THE OREGON REVISED STATUTES**

WHEREAS, the City of Sherwood received a petition to vacate portions of the right-of-way of Meinecke Road south of Highway 99 consistent with ORS 271.080;

WHEREAS, the City Council passed Resolution 2003-078 scheduling a public hearing for the vacation consistent with ORS 271.110;

WHEREAS, the City provided notice of and conducted a hearing on the vacation consistent with ORS 197.763 and 271.110;

WHEREAS, pursuant to ORS Chapter 374 and its implementing rules the Oregon Department of Transportation has the authority to permit or deny access to a state highway including 99W;

WHEREAS, the vacation of public right-of-way adjacent to 99W by the City of Sherwood is not intended to provide or infer any present or future right of access to that transportation facility; and

WHEREAS, after considering the testimony and evidence presented in the record as a whole, the City Council determined that it is in the public interest to vacate the southern portion of Meinecke Road south of 99W excluding a slope easement and utility easement as provided herein.

NOW THEREFORE, BASED ON THE FOREGOING, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:

Section 1. The City Council hereby orders the vacation of the public right-of-way reserving a fifteen (15) foot wide slope easement and eight (8) foot wide utility easement as set forth on Exhibit A, B, and C ("old alignment").

Section 2. In support of the decision to vacate the old alignment, the City Council hereby finds:

- A. **CONSENTS.** ORS 271.080(2) requires the consent of all abutting property and of not less than two-thirds in area of the real property affected thereby. Attached to the REQUEST FOR VACATION – MEINECKE ROAD in the record is a matrix of

signatures received from property owners within the vacation area. All of the adjacent property owners consent to the proposed annexation. Those property owners own approximately 87.11% of the land within the vacation area. The City Council finds that sufficient consents are present in the record consistent with ORS 271.080(2);


- B. PUBLIC INTEREST. ORS 271.120 prohibits vacation of an area if such vacation will prejudice the public interest. All existing property owners will continue to have access to their property after vacation of the old alignment for Meinecke Road. The new alignment of Meinecke Road provides additional capacity and functional serves the same purpose for traffic circulation in the area as the old alignment. As such the City Council finds that the public interest will not be prejudiced by this vacation.
- C. RECOMMENDATION OF THE CITY ENGINEER. The recommendation from the City Engineer dated November 4, 2003 is hereby incorporated as findings in support of the decision to vacate the original alignment.

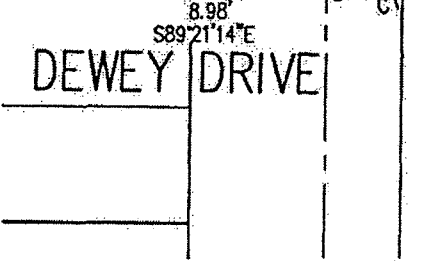
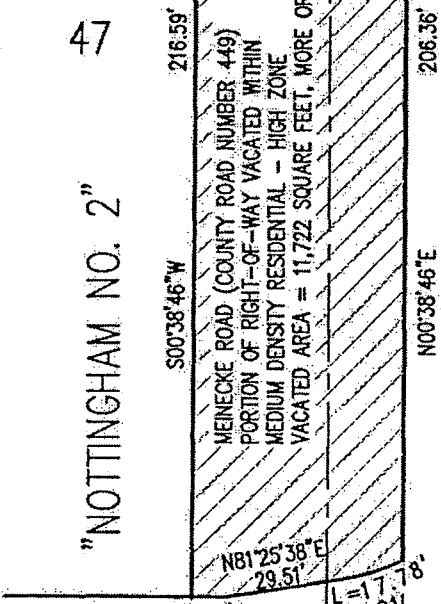
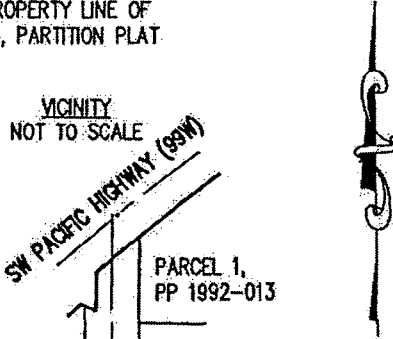
LOCATED IN THE NE 1/4 AND NW 1/4 OF SECTION

A portion of Meinecke Road (County Road Number 449) located in the Northeast ¼ and Northwest ¼ of Section 31, Township 2 South, Range 1 West, Willamette Meridian, City of Sherwood, Washington County, Oregon. The beginning of said road lies 6.00 feet west of the North Quarter Corner for Section 31, as described in the county road notes.
