THIS GRANT OF A PUBLIC UTILITY EASEMENT is made by and between DUCK COUNTRY APARTMENTS LLC, an Oregon limited liability company, its successors and assigns ("Grantor") and the City of Sherwood, an Oregon municipal corporation, its successors and assigns ("Grantee" or "City") for the consideration hereinafter stated. - 2. A map of the above legal description is set forth in EXHIBIT "B," attached and incorporated by reference.




