THIS GRANT OF A PUBLIC UTILITY EASEMENT is made by and between the City of Sherwood, an Oregon municipal corporation, its successors and assigns ("Grantor" or "City") and Portland General Electric Company its successors and assigns ("Grantee") for the consideration hereinafter stated. The public utility easement exists over, under, through, across and along the full width and length of the premises described as follows, ("Easement Area") to wit:

- 2. A map of the above legal description is set forth in EXHIBIT "B," attached and incorporated by reference.

The true consideration for this conveyance is \$4,567.42. However, the actual consideration consists of other value given, which value constitutes the whole consideration.

This document is intended to establish a permanent non-exclusive easement on the property described, not to convey fee title or any interest in the underlying property except as expressly stated herein. The easement granted shall not prevent Grantor from the use of said property provided, however, that such use shall not be permitted to interfere with the rights herein granted. Grantor shall not be permitted to endanger the lateral support of any facilities constructed within the easement granted herein.

Grantee shall have the right to use the property for utility purposes, including but not limited to electrical utility purposes and shall have the right to install, construct, operate, maintain, repair, replace and reconstruct said facilities as Grantee may reasonably deem necessary over, across, through, in and under the property described in Exhibits "A" and "B."

Grantee upon the initial installation (as applicable) and upon each and every occasion that the same be repaired, replaced, renewed, added to, or removed, will restore the premises of the Grantors, and any improvements disturbed by the City, to as good condition as they were prior to any such installation work, including, but not limited to, the restoration of any topsoil, pavement, lawn and nursery stock of like kind and quality subject to reasonable substitution as may be necessitated by obstruction of interference with the use granted herein. Grantee shall not assign this easement without the written consent of Grantor.
