

## **RESOLUTION 2019-083**

## APPOINTING MEMBERS TO THE SHERWOOD SENIOR ADVISORY BOARD

**WHEREAS**, on June 18, 2019, the City Council adopted Ordinance 2019-005, creating a new chapter within the Sherwood Municipal Code; and

**WHEREAS**, that Chapter, SMC Chapter 2.08, established a Senior Advisory Board and provided consistency within a number of areas, including the size of boards and commissions, lengths of terms, eligibility, and appointment processes; and

WHEREAS, all nine positions on the Senior Advisory Board are currently vacant; and

**WHEREAS**, the term of office for these positions varies depending on position number, due to the staggering of terms for new City boards and commissions described in SMC 2.08.055; and

WHEREAS, the City advertised the vacant positions and sought interested applicants; and

**WHEREAS**, City Councilor Renee Brouse, Senior Center Manager Maiya Martin Burbank, and Community Services Director Kristen Switzer interviewed applicants and made recommendations regarding appointments to Mayor Keith Mays; and

WHEREAS, Mayor Keith Mays has recommended nine individuals for appointment; and

**WHEREAS**, in accordance with Council Rules, all such appointments are subject to the approval of the City Council by resolution.

## NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

- <u>Section 1.</u> The Sherwood City Council hereby appoints nine individuals to the Sherwood Senior Advisory Board as set forth in Exhibit A.
- Section 2. This Resolution shall be effective upon its approval and adoption.
