#### Issue:

Shall the Sherwood Urban Renewal Agency Board of Directors authorize the Agency Manager to sign an Intergovernmental Agreement (IGA) with the City of Sherwood for the Sherwood Broadband Project?

#### **Background:**

The Sherwood 2021 Urban Renewal Plan describes a Sherwood Broadband Installation project, which broadly will consist of installation of fiber optic cables and related infrastructure throughout the Plan area as part of a larger project to install fiber optic cables and related infrastructure throughout the City in order to establish an interconnected City-wide fiber optic cable network capable of providing broadband internet services throughout the City.

Because this project spans across areas inside the Plan area as well as outside the Plan area, it is necessary for the URA to coordinate with the City on this project. This resolution would authorize the Agency Manager to sign an Intergovernmental Agreement with the City under which the City would manage the project and costs for the work would be allocated between the City and URA.

### **Financial Impacts:**

Costs for this project have been included in the FY 2022-2023 budget for the 2021 URA.

#### **Recommendation:**

Staff respectfully recommends URA Board approval of URA Resolution 2022-004, Authorizing an Intergovernmental Agreement with the City of Sherwood for the Sherwood Broadband Project.



### **URA RESOLUTION 2022-004**

### AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF SHERWOOD FOR THE SHERWOOD BROADBAND PROJECT

WHEREAS, the Sherwood 2021 Urban Renewal Plan ("Plan") describes a Sherwood Broadband Installation project, which broadly will consist of installation of fiber optic cables and related infrastructure throughout the Plan area as part of a larger project to install fiber optic cables and related infrastructure throughout the City in order to establish an interconnected City-wide fiber optic cable network capable of providing broadband internet services throughout the City; and

**WHEREAS,** because this project spans across areas inside the Plan area as well as outside the Plan area, it is necessary for the URA to coordinate with the City on this project; and

**WHEREAS**, under the terms of the intergovernmental agreement attached hereto as Exhibit A, the City would manage the project and costs for the work would be allocated between the City and URA.

## NOW, THEREFORE, THE SHERWOOD URBAN RENEWAL AGENCY BOARD RESOLVES AS FOLLOWS:

- **Section 1.** The Agency Manager is hereby authorized to sign an intergovernmental agreement in a form substantially similar to the attached Exhibit A.
- **Section 2.** This Resolution shall be effective upon its approval and adoption.

### INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF SHERWOOD AND THE SHERWOOD URBAN RENEWAL AGENCY

This Intergovernmental Agreement ("Agreement") is entered into by and between the City of Sherwood, Oregon ("City"), a municipal corporation, and the Sherwood Urban Renewal Agency ("URA"), a municipal corporation, effective on the date last set forth below; and

**WHEREAS**, the URA is charged with administering the Sherwood 2021 Urban Renewal Plan (the "Plan") as approved by the City Council through Ordinance 2021-005 on May 18, 2021; and

WHEREAS, the City provides financial, administrative, and other support services to the URA; and

**WHEREAS,** pursuant to ORS 190.010, the City and URA are authorized to enter into intergovernmental agreements for the performance of tasks either is authorized by law to perform; and

**WHEREAS,** the Plan describes a Sherwood Broadband Installation project, which broadly will consist of installation of fiber optic cables and related infrastructure throughout the City in order to establish an interconnected City-wide fiber optic cable network capable of providing broadband internet services throughout the City (the "Broadband Project"); and

WHEREAS, both URA and City desire to see the Broadband Project completed; and

**WHEREAS,** completion of the Broadband Project will include installation of fiber optic cables and other infrastructure in areas within the Plan area and areas outside the Plan area; and

**WHEREAS,** URA has available financial resources and desires to be financially responsible for the costs of the Broadband Project to the extent the work occurs inside the Plan area; and

**WHEREAS**, City has available financial resources and desires to be financially responsible for the costs of the Broadband Project to the extent the work occurs outside the Plan area; and

**WHEREAS**, URA desires for City to be responsible for the overall management of the Broadband Project, including but not limited to hiring and managing of construction and other necessary contractors, purchasing and storing of materials and supplies, and performing construction and other necessary work with City staff; and

WHEREAS, City is willing and able to perform said duties in connection with this project.

### NOW, THEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. City Duties and Responsibilities. The City shall:

- a. Provide overall management of the Broadband Project, including but not limited to hiring and managing of construction and other necessary contractors, purchasing and storing of materials and supplies, and performing construction and other necessary work with City staff.
  b. For each invoice received by City for work on the Broadband Broject performed by
- b. For each invoice received by City for work on the Broadband Project performed by contractors, allocate the invoiced amount between City and URA based on the percentage of the work performed within and without the boundaries of the Plan area.
- c. For work performed on the Broadband Project performed by City staff, allocate the actual cost of said work between City and URA based on the percentage of the work performed within and without the boundaries of the Plan area.
- d. For all costs which are allocated to the URA under subsections 1(b) and 1(c) above, timely submit invoices to URA.
- e. Be financially responsible for all costs which are allocated to the City under subsections 1(b) and 1(c) above.

### 2. URA Duties and Responsibilities. The URA shall:

a. Timely pay all invoices received from City under subsection 1(d) above.

### 3. Additional Terms

- a. Severability. If any section, clause, or phrase of this Agreement is judicially deemed invalid, illegal, or unenforceable in any respect, the remaining parts of this Agreement shall be severed from the invalid parts and remain in full force and effect.
- b. Modification. This Agreement may be modified only by mutual written consent of the parties.
- c. Term and Termination. This Agreement shall remain in effect until terminated by the parties as provided herein. This Agreement may be terminated by mutual written consent of the parties. Termination of this Agreement shall not affect the duties and obligations of the parties that accrued prior to termination, including any bond loan or other repayment obligation.

## SUBJECT: URA Resolution 2022-005, Transferring budget expenditure appropriations between categories for Fiscal Year 2021-22

### Issue:

Shall the Board approve the transfer of budget expenditure appropriations as presented for fiscal year 2021-22?

### Background:

Pursuant to ORS 294.463, Oregon Municipalities can transfer appropriation between existing categories during the budget year. Our practice over the past years is to perform such transfers generally twice per year, once around mid-fiscal year and then at the end of the fiscal year, if necessary.

In December and June of every year, Bank of America auto withdrawals their semiannual debt service payments from the URA's pooled cash account. These payments are in accordance with the payment schedule outlined in the 2010 loan.

In June of 2021, Bank of America auto withdrew their interest payment but failed to withdraw the \$5,000 principal payment. During month end closing in July this error was noticed by staff. Bank of America was immediately contacted, and the situation was corrected. This item was unanticipated at the time the budget was adopted.

### **Financial Impacts:**

There is a small financial impact from adoption of this resolution. The URA was charged an additional \$112.78 in interest on this debt service payment. This additional interest charge will be addressed with the Bank next fiscal year when this URA begins winding up operations.

### **Recommendation:**

Staff respectfully recommends approval of URA Resolution 2022-005, transferring budget expenditure appropriations between categories for fiscal year 2021-22.

**WHEREAS,** the Urban Renewal Agency Budget Committee has reviewed and acted on the proposed Original Urban Renewal Agency budget; and

**WHEREAS,** the Budget Committee approved and recommended a balanced budget to the Urban Renewal Agency Board of Directors on June 13, 2022; and

**WHEREAS**, in accordance with State law, on June 29, 2022, the Urban Renewal Agency Board of Directors held a public hearing on the budget as approved and recommended by the Budget Committee; and

# NOW, THEREFORE, THE SHERWOOD URBAN RENEWAL AGENCY BOARD RESOLVES AS FOLLOWS:

<u>Section 1.</u> <u>Adoption of the FY2022-23 Budget</u>. The Board of Directors of the Urban Renewal Agency of the City of Sherwood, Oregon hereby adopts the budget for the City of Sherwood Original Urban Renewal Agency for fiscal year 2022-23 in the sum of \$5,078,038 now on file at City Hall, and attached hereto as Exhibit A.

**Section 2. Making Appropriations.** The amounts for the fiscal year beginning July 1, 2022 and for the purposes shown below are hereby appropriated as follows:

- <u>Section 3.</u> Imposing and Categorizing Taxes. The Board of Directors of the Urban Renewal Agency of the City of Sherwood hereby resolves to certify to the county assessor a request for the Urban Renewal District Old Town Plan Area in the amount of \$1,503,800 that may be raised by dividing the taxes under Section 1c, Article IX of the Oregon Constitution and ORS Chapter 457.
- <u>Section 4:</u> Agency Manager Authorization. The Urban Renewal Agency Manager is hereby authorized to take such action as is necessary to carry out the adopted budget.
- **Section 5:** Effective Date. This Resolution shall be effective upon its approval and adoption.



### **About the Agency**

The Urban Renewal Agency (URA) is a separate entity from the City of Sherwood. The Sherwood City Council serves as the Board of Directors for the URA and is financially accountable for its operations. In accordance with Oregon budget law, the URA prepares its own budget, and the Board of Directors approves its annual appropriations.

Urban renewal agencies are designed to borrow money and make expenditure for economic and community development projects included in the Urban Renewal Plan. When the Sherwood Urban Renewal Plan was adopted in 2000, property values were frozen. The taxes collected on that frozen value continues to flow to the taxing authorities (City, County, Schools, TVF&R, etc.). The taxes collected on increased property values that typically occur with new development generate incremental tax revenue. This tax increment is then used to repay the URA debt and implement the URA plan.

In 2012 the URA plan was amended. The Maximum Indebtedness was increased and starting in 2014 a portion of the new tax revenue has been shared with the other taxing authorities. The net effect of the additional shared revenue will be to keep the district open for one additional year.

In 2020 the URA boundary was amended by reducing the Plan area. The remaining boundary of the Plan is judged to be sufficient to provide for the tax increment revenues necessary to make debt service payments. The Agency is projected to close in FY2022-23.

Urban Renewal tax collections are not an additional tax. Urban Renewal tax collections are used to initiate development that would not be financially feasible without infrastructure improvements made possible by urban renewal financing.



### **Urban Renewal District Assessed Value**

### **Budget Message**

It is my privilege to provide you, the citizens of the City of Sherwood, with the proposed Urban Renewal Agency (URA) budget for Fiscal Year 2022-23 (FY2022-23).

The Agency budget consists of one fund which covers both operations and capital. The operations for the Agency include administration costs and economic development activities within the Urban Renewal Area. The capital is for construction projects and property purchases. All of the projects funded through URA capital are transferred to City ownership upon completion.

The Agency operates under direction from the Agency Board of Directors.

### FY2022-23 Proposed Budget

The proposed FY2022-23 budget consists of personal services, allocated overhead, and material and services expenses needed to continue to administer the URA in preparation of its closure. Debt service payments account for 94% of the proposed expenditures.

The proposed FY2022-23 Capital Projects budget does not have any appropriations this year as the Agency is beginning the process of wrapping up operations. As previously mentioned, the Agency is projected to close in FY2022-23.

The Agency will continue to focus on, considering the potential sale of property and preparing the URA to wrap up operations by paying off the URA debt in FY2022-23, depending on tax increment revenue. We are looking forward to the ultimate closure of this successful Urban Renewal Agency in the near future.

### **URA RESOLUTION 2022-007**

**WHEREAS,** the Urban Renewal Agency Budget Committee has reviewed and acted on the proposed 2021 Urban Renewal Agency budget; and

**WHEREAS,** the Budget Committee approved and recommended a balanced budget to the Urban Renewal Agency Board of Directors on June 13, 2022; and

**WHEREAS**, in accordance with State law, on June 29, 2022, the Urban Renewal Agency Board of Directors held a public hearing on the budget as approved and recommended by the Budget Committee; and

**WHEREAS**, the Urban Renewal Agency Board of Directors desires to adopt the approved budget and carry out the programs identified in the budget.

NOW, THEREFORE, THE SHERWOOD URBAN RENEWAL AGENCY BOARD RESOLVES AS FOLLOWS:

<u>Section 1.</u> <u>Adoption of the FY2022-23 Budget</u>. The Board of Directors of the Urban Renewal Agency of the City of Sherwood, Oregon hereby adopts the budget for the City of Sherwood 2021 Urban Renewal Agency for fiscal year 2022-23 in the sum of \$24,566,561 now on file at City Hall, and attached hereto as Exhibit A.






### **About the Agency**

The 2021 Urban Renewal Agency (URA) is a separate entity from the City of Sherwood. The Sherwood City Council serves as the Board of Directors for the URA and is financially accountable for its operations. In accordance with Oregon budget law, the URA prepares its own budget, and the Board of Directors approves its annual appropriations.

Urban renewal agencies are designed to borrow money and make expenditure for economic and community development projects included in the Urban Renewal Plan. When the Sherwood 2021 Urban Renewal Plan was adopted in 2021, property values were frozen. The taxes collected on that frozen value continues to flow to the taxing authorities (City, County, Schools, TVF&R, etc.). The taxes collected on increased property values that typically occur with new development generate incremental tax revenue. This tax increment is then used to repay the URA debt and implement the URA plan.

Urban Renewal tax collections are not an additional tax. Urban Renewal tax collections are used to initiate development that would not be financially feasible without infrastructure improvements made possible by urban renewal financing.

### **Budget Message**

It is my privilege to provide you, the citizens of the City of Sherwood, with the proposed 2021 Urban Renewal Agency (URA) budget for Fiscal Year 2022-23 (FY2022-23).

The Agency budget consists of two funds: a General Operating Fund and a Capital Projects Fund. The Operating Fund is used to account for Agency administration costs and some economic development activities within the Urban Renewal Area. The Capital Projects Fund is used to account for construction projects and property purchases. All of the projects funded through the URA Capital Projects Fund are transferred to City ownership upon completion.

The Agency operates under direction from the Agency Board of Directors.

### FY2022-23 Proposed Budget

The proposed FY2022-23 Operations Fund budget consists of personal services, allocated overhead, and material and services expenses needed to continue administering the URA. Debt service payments account for 92% of the proposed expenditures.

The proposed FY2022-23 Capital Projects Fund budget primarily includes appropriations for design and construction of Festival Plaza, portions of Sherwood Broadband, a High-Arched Pedestrian Bridge across Highway 99W, Ice Age Drive and a new Public Works Facility. Funding for these projects will come from tax increment revenue and loans.

This promises to be an exciting year for the Agency. Projects that have lived in the imaginations of elected officials and Sherwood citizens for years are beginning. I am looking forward to an active year of Agency progress and community achievement.

**Sherwood Broadband:** Sherwood Broadband is a community owned all-fiber network providing broadband service to businesses and residents of Sherwood. The network needs to be expanded to include the ability to provide broadband service in the area.

Pedestrian Bridge: Design and construct a pedestrian bridge across 99W, Elwert and Kruger.

**Ice Age Drive**: Design Ice Age Drive in the Tonquin Employment Area to provide an east/west collector between Oregon Street and 124<sup>th</sup>.

Public Works Facility: Design a new Public Works Facility.
