#### Issue:

Shall the Board approve the transfer of budget expenditure appropriations as presented for fiscal year 2022-23?

#### **Background:**

Pursuant to ORS 294.463, Oregon Municipalities can transfer appropriation between existing categories during the budget year. Our practice over the past years is to perform such transfers generally twice per year, once around mid-fiscal year and then at the end of the fiscal year, if necessary.

This URA Plan is in the process of wrapping up this fiscal year. One of the steps to accomplish this is to retire (pay off) all existing debt. Additional funds were needed to pay off the final two existing loans. This additional cost was unanticipated at the time the budget was adopted.

Additionally, once the books are closed for the prior fiscal year, the Plan must calculate the remaining funds left before the Plan reaches its maximum indebtedness. Additional administrative costs were able to be allocated to this URA Plan to reach this Plans maximum indebtedness. This additional cost was unanticipated at the time the budget was adopted.

The Plan has reached the \$45,133,469 maximum indebtedness dollar limit and retired (paid off) all existing outstanding debt.

#### **Financial Impacts:**

There are no financial impacts from adoption of this resolution as we are transferring budget expenditure appropriations between categories.

#### Recommendation:

Staff respectfully recommends approval of URA Resolution 2023-006, Original URA transferring budget expenditure appropriations between categories for fiscal year 2022-23.

#### **Background:**

Pursuant to ORS 294.463, Oregon Municipalities can transfer appropriation between existing categories during the budget year. Our practice over the past years is to perform such transfers generally twice per year, once around mid-fiscal year and then at the end of the fiscal year, if necessary.

Oregon law requires local governments to file annual financial reports and other items to the Secretary of State Audits Division. The audits and reviews shall be completed by an independent accountant who is listed on a roster maintained by the Oregon Board of Accountancy. This was the 2021 URA's first annual audit and the cost of this audit was higher than originally anticipated. This additional cost was unanticipated at the time the budget was adopted.

Additionally, the 2021 URA had printing and advertising costs during the fiscal year. This additional cost was unanticipated at the time the budget was adopted.

#### **Financial Impacts:**

There are no financial impacts from adoption of this resolution as we are transferring budget expenditure appropriations between categories.

**WHEREAS**, the Urban Renewal Agency Budget Committee has reviewed and acted on the proposed 2021 Urban Renewal Agency budget; and

**WHEREAS**, the Budget Committee approved and recommended a balanced budget to the Urban Renewal Agency Board of Directors on June 1, 2023; and

**WHEREAS,** in accordance with State law, on June 20, 2023, the Urban Renewal Agency Board of Directors held a public hearing on the budget as approved and recommended by the Budget Committee; and

**WHEREAS**, the Urban Renewal Agency Board of Directors desires to adopt the approved budget and carry out the programs identified in the budget.

NOW, THEREFORE, THE SHERWOOD URBAN RENEWAL AGENCY BOARD RESOLVES AS FOLLOWS:

<u>Section 1.</u> <u>Adoption of the FY2023-24 Budget</u>. 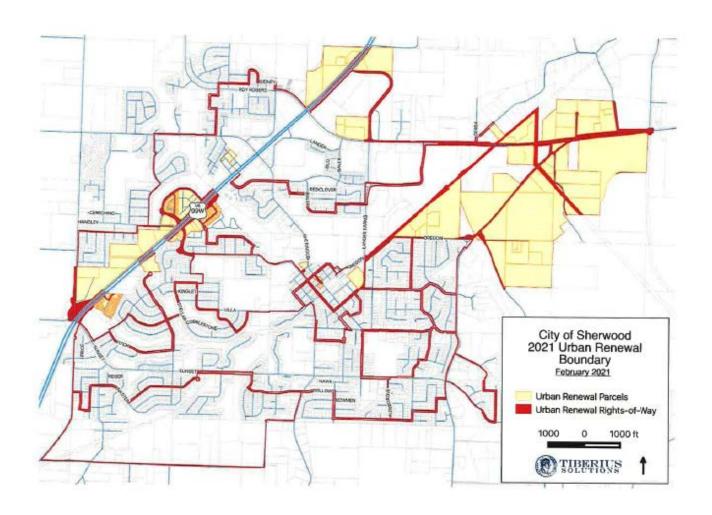

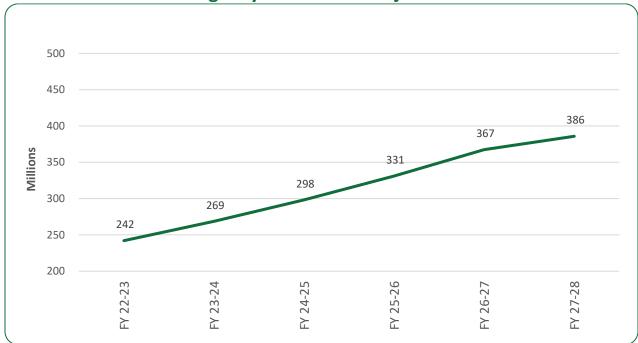
#### **About the Agency**

The 2021 Urban Renewal Agency (URA) is a separate entity from the City of Sherwood. The Sherwood City Council serves as the Board of Directors for the URA and is financially accountable for its operations. In accordance with Oregon budget law, the URA prepares its own budget, and the Board of Directors approves its annual appropriations.

Urban renewal agencies are designed to borrow money and make expenditure for economic and community development projects included in the Urban Renewal Plan. When the Sherwood 2021 Urban Renewal Plan was adopted in 2021, property values were frozen. The taxes collected on that frozen value continues to flow to the taxing authorities (City, County, Schools, TVF&R, etc.). The taxes collected on increased property values that typically occur with new development generate incremental tax revenue. This tax increment is then used to repay the URA debt and implement the URA plan.

Urban Renewal tax collections are not an additional tax. Urban Renewal tax collections are used to initiate development that would not be financially feasible without infrastructure improvements made possible by urban renewal financing.

#### **Budget Message**

It is my privilege to provide you, the citizens of the City of Sherwood, with the proposed 2021 Urban Renewal Agency (URA) budget for Fiscal Year 2023-2024 (FY2023-24).

The Agency budget consists of two funds: a General Operating Fund and a Capital Projects Fund. The Operating Fund is used to account for Agency administration costs and some economic development activities within the Urban Renewal Area. The Capital Projects Fund is used to account for construction projects and property purchases. All of the projects funded through the URA Capital Projects Fund are transferred to City ownership upon completion.

The Agency operates under direction from the Agency Board of Directors.

#### FY2023-24 Proposed Budget

The proposed FY2023-24 Operations Fund budget consists of personal services, allocated overhead, and material and services expenses needed to continue administering the URA. Debt service payments account for 70% of the proposed expenditures.

The proposed FY2023-24 Capital Projects Fund budget primarily includes appropriations for design and construction of a High-Arched Pedestrian Bridge across Highway 99W and Ice Age Drive. Funding for these projects will come from tax increment revenue and loans.

This promises to be another exciting year for the Agency. Projects that have lived in the imaginations of elected officials and Sherwood citizens for years are proceeding through meticulous planning and design. I am looking forward to another active year of Agency progress and community achievement.

A. URA Resolution 2023-008, Adopting the FY2023-24 budget of the City of Sherwood 2021 Urban Renewal Agency, making appropriations, imposing and categorizing taxes, and authorizing the Agency Manager to take such action necessary to carry out the adopted budget

Finance Director David Bodway stated that this resolution pertained to the newer URA and recapped that the URA Budget Committee had received the budget message, reviewed the proposed budget, heard public comment, and approved the proposed budget on June 1<sup>st</sup>. He stated that the final step in the process was to hold a final public hearing on the proposed resolution and to then adopt the Fiscal

Year 2023-24 budget for the 2001 URA. Mr. Bodway asked for discussion or questions from the Board. Chair Rosener opened the public hearing portion of the meeting and asked for comment or discussion on the proposed resolution. Vice Chair Mays commented that he was excited to have the new 2021 URA and explained that this demonstrated how Sherwood utilized its urban renewal authority that was authorized by the state. Chair Rosener opened the public hearing and asked for public comment. Hearing none, Chair Rosener closed the public hearing and asked for discussion or motion from the Board. With no further comments or discussion, the following motion was stated.

MOTION: FROM KIM YOUNG TO APPROVE URA RESOLUTION 2023-008, ADOPTING THE FY2023-24 BUDGET OF THE CITY OF SHERWOOD 2021 URBAN RENEWAL AGENCY, MAKING APPROPRIATIONS, IMPOSING AND CATEGORIZING TAXES, AND AUTHORIZING THE AGENCY MANAGER TO TAKE SUCH ACTION NECESSARY TO CARRY OUT THE ADOPTED BUDGET. SECONDED BY RENEE BROUSE. MOTION PASSED 6:0. ALL PRESENT MEMBERS VOTED IN FAVOR (DAN STANDKE WAS ABSENT).
