Increment Collections for the Sherwood Old Town Urban Renewal Plan

#### Issue:

Shall the Sherwood Urban Renewal Agency (URA) authorize the Agency Manager to Terminate Tax Increment Collections for the Sherwood Old Town Urban Renewal Plan?

#### **Background:**

The Sherwood Old Town Urban Renewal Plan (Plan) was approved by City Council on August 29, 2000 with Ordinance No. 2000-1098. Maximum Indebtedness (MID) became a requirement in 1998 pursuant to the provisions of Chapter 457 of the Oregon Revised Statutes (ORS). The Plan's initial MID was \$35,347,600 but was increased by an amendment in 2012 to \$45,133,469.

The Plan has reached the \$45,133,469 maximum indebtedness dollar limit and today has retired (paid off) all existing outstanding debt. ORS 457.450(2) requires the URA to notify the assessor to terminate the collection of tax increment revenues when the urban renewal plan's maximum debt is, or can be, retired. The tax increment termination would be effective July 1, 2023 and any excess increment collected in excess of that needed to retire all outstanding debt, will be returned back to the assessor at Washington County at the end of the current fiscal year.

#### **Financial Impacts:**

There are no financial impacts expected this fiscal year. The termination will release all tax increment collections for this plan going forward from July 1, 2023 to the overlapping tax districts, including approximately \$289,000 to the City of Sherwood.

#### Recommendation:

Staff respectfully recommends approval of URA Resolution 2023-005, Authorizing the Agency Manager to Terminate Tax Increment Collections for the Sherwood Old Town Urban Renewal Plan.



#### **URA RESOLUTION 2023-005**

#### AUTHORIZING THE AGENCY MANAGER TO TERMINATE TAX INCREMENT COLLECTIONS FOR THE SHERWOOD OLD TOWN URBAN RENEWAL PLAN

**WHEREAS**, the Sherwood Old Town Urban Renewal Plan (Plan) was adopted by City Ordinance No. 2000-1098 on August 29, 2000; and

**WHEREAS**, collection of the tax increment funds for every urban renewal plan is limited by the plan's stated maximum indebtedness: and

**WHEREAS**, the plans maximum indebtedness (MID) was adopted by City Ordinance No. 2000-1098 on August 29, 2000 in the amount of \$35,347,600; increased to \$45,133,469 by a plan amendment in 2012: and

**WHEREAS**, ORS 457.450 (2) requires the Urban Renewal Agency to notify the assessor to terminate the collection of tax increment revenues when the urban renewal plan's maximum debt is, or can be, retired: and

**WHEREAS**, the Plan has reached the \$45,133,469 maximum indebtedness dollar limit and today has retired (paid off) all existing outstanding debt.

NOW, THEREFORE, THE SHERWOOD URBAN RENEWAL AGENCY BOARD RESOLVES AS FOLLOWS:

To notify the assessor of Washington County to terminate the collection of tax increment revenue for the Plan effective July 1, 2023.
