1. Call to Order

Vice Chair Yandt called the meeting to order at 6:05 p.m.

2. Roll Call

Committee Members Present: Vice Chair Tiffany Yandt, Tony Bevel, Dorian Libal, Lisa Patterson, Diane Foster and Laurie Zwingli

Committee Members Absent: Chair Jason Wuertz

3. Approval of Minutes

Ms. Foster moved that the October meeting minutes be approved as written and Mr. Libal seconded the motion. All present committee members voted in favor.

4. Business

a. Welcome New Member, Lisa Patterson

Vice Chair Yandt welcomed the newest Traffic Safety Committee member, Lisa Patterson. She also welcomed the new Sherwood PD Police Chief, Ty Hanlon.

b. Issues / Complaints

i. Tracking Sheets (2020-2022) Review (Exhibit "A")

Please refer to the Tracking Sheets for more information on the requests discussed at this meeting.

Captain Carlson let everyone know that, per the budget, all of the money that had been slotted for the Traffic Safety Committee (TSC) has been allocated out for this fiscal year. The monies have gone towards the street light project (#2020-012) at Sunset Blvd and Main, traffic count studies, etc.

ii. Update: 2020-012, Status / Progress Update, Captain Carlson

The discussion for this request begins at the 3:18 minute mark of the YouTube video. Captain Carlson stated that the City Manager has approved this project and Public Works is currently waiting on materials. Receipt of the materials is 12-14 weeks out. They are hoping for a springtime completion date.

Ms. Zwingli wasn't aware that the TSC is allocated a budget and wondered what the budget is. Captain Carlson replied that the TSC is allocated \$100,000.00 every fiscal year.

iii. Update: 2021-004, Status / Progress Update, Captain Carlson

The discussion for this request begins at the 5:05 minute mark of the YouTube video. Captain Carlson was originally told that Public Works would be able to paint the pedestrian crossing striping lines in a few months, but with the recent nice weather, the painting has already been completed. The reconstruction of the truncated domes, in order to meet ADA standards, is on the Public Works Department's list. This is part of a larger project down the road.

iv. Update: 2021-005, Status / Progress Update, Captain Carlson

The discussion for this request begins at the 6 minute mark of the YouTube video. Captain Carlson reported that the City Manager has approved funding in order to conduct a pedestrian count study from an outside firm. As it had just been approved, he wasn't sure of the time line. Mr. Galati shared that he had the traffic count scheduled for the next Saturday. He will contact DKS about starting on the pedestrian counts, now that the City Manager has approved this.

v. Update: 2021-006, Status / Progress Update, Mr. Galati

The discussion for this request begins at the 7:20 minute mark of the YouTube video. Captain Carlson asked Mr. Galati if he had been able to collect the necessary data for this request. Mr. Galati stated that he had contacted Public Works about painting the approved striping. Captain Carlson stated that he would check in with Public Works about their anticipated completion date.

vi. Update: 2021-008, Safety Concerns for Crossing at Sunset & Timbrel

The discussion for this request begins at the 8:35 minute mark of the YouTube video. Captain Carlson stated that this request is regarding the safety concerns with the crossing at Sunset and Timbrel. He had forwarded a part of this request on to the Sherwood School District (SSD) as there were portions that they would need to address. He had just received a response back from the SSD that day, so the TSC had not seen it yet. He went on to read the SSD's response. One of the things mentioned was that the SSD would like to work with the City on getting a grant to help pay for flashing crosswalk lights at that intersection. After some discussion, the committee members agreed that this would best be handled with two separate motions.

Ms. Zwingli made a motion for Captain Carlson to reach out to the SSD to see if crossing guards can lengthen their time at the crosswalk in the mornings (until 8:15) and afternoons (3:45-4), to accommodate the high school students and if they can adjust the scheduled times for the school zone beacons. Also, ask the SSD about the possibility of further discussions regarding grant options. Ms. Foster seconded the motion.

Ms. Patterson made a second motion to get speed and pedestrian counts (approximately \$1,300-\$1,500) completed. Mr. Libal seconded the motion.

All present committee members voted in favor of both motions.

vii. NEW: 2022-001, Handley & Roellich Pedestrian Crossing (Exhibit "B")

The discussion for this request begins at the 39:40 minute mark of the YouTube video. Vice Chair Yandt read the new complaint aloud. This was a request received by Mayor Mays and the City of Sherwood in March of 2019. The new City Manager has asked that the TSC review the complaint and the data collected by the City Engineer. The meeting packet contained the photos and data collected by the City.

Some of these issues are similar to other requests received.

Mr. Galati explained that the original complaint came from a resident that lived in the apartments along Cedar Brook Way, in regards to how their school age children crossed the street to get to the elementary school. People were turning onto Roellich without stopping.

Mr. Galati took pictures of the intersection to see if there were any sight impediments to a driver seeing a pedestrian wanting to cross the street. In looking at the photos, there really aren't any impediments from seeing people waiting to cross. The ask from the requestor was to put an "all ways" stop at that intersection.

His initial exhibit shows where stop signs and bars could be placed. There are many driveways that come out into the intersection, which could be problematic. He wasn't sure if making it a three way stop would be advisable. He added that this is not the only crossing. The City Manager at the time this request came in asked Mr. Galati how many accidents had occurred there. Mr. Galati stated that he was not aware of any. The former City Manager also inquired as to how much money it would cost for all of the work to be completed. Mr. Galati had replied that the cost would be \$3,000-\$5,000 for each intersection (five) for a total of \$15,000-\$25,000. He was also asked how many other complaints had been received and Mr. Galati replied that there had only been one other, that he knew of.

Ms. Patterson asked if since this request was from 2019, prior to when the new high school was built, could there now be issues that weren't there before. Mr. Galati replied that speeding may be an issue and the volume of vehicles on Handley has gone up considerably. This, however, is a separate issue. He could potentially do a study on the traffic and speeds on Handley, but was not sure if the request at that particular location is a standalone. They would have to take a look at the entirety of Handley Street.

After further discussion, Mr. Libal made a motion to ask Captain Carlson to increase the police presence on Handley during the morning commute times for school and work traffic and again in the afternoons when kids get out of school. This will help the TSC to better determine if there is a problem and then they can go from there. Ms. Zwingli seconded the motion. All present committee members voted in favor.

viii. NEW: 2022-002, No Parking Stripes on Each Side Street Corner in Old Town (Exhibit "C")

The discussion for this request begins at the 1 hour, 9:40 minute mark of the YouTube video. Mr. Galati provided a brief description on the parking situation in Old Town. He is seeing people parking in areas that they shouldn't be. Public Works has painted in parking stalls, but people ignore those. He said they could, potentially, bump out the curb lines, but he doesn't feel that is a good option. The streets are pretty narrow. He feels that this request would be best dealt with by education. Drivers aren't supposed to block pedestrian crossings or park by or block a stop sign. There are already signs up that are being ignored. He recommended education to start with. Notifying the public of the standards. Ms. Patterson wondered if the first ticket could be a warning. Ms. Zwingli thought that was a good idea and mentioned that is similar to what they recommended on Woodhaven by the YMCA. Captain Carlson stated that the PD could do that. Mr. Bevel shared his thoughts as well.

It was suggested that the PD conduct educational enforcement for a month and ask the City to help get the word out and see what kind of feedback is received in a month or so. Ms. Patterson asked who would be the ones to put that together. Captain Carlson said that the PD and the City have several different social media outlets.

Ms. Patterson made a motion for the PD and the City of Sherwood to help get out educational outreach through social media posts regarding parking in Old Town for the next month. Ms. Zwingli seconded the motion. All present committee members voted in favor.

ix. NEW: 2022-003, Intersection at Park & 1st in Old Town (Exhibit "D")

The discussion for this request begins at the 1 hour, 23 minute mark of the YouTube video. As this issue is very similar to 2022-002, Ms. Zwingli suggested that what is being done with 002 might help with this request. Ms. Zwingli made a motion to take a look at this request again, after they get feedback from request 2022-002. Mr. Libal seconded the motion and all present committee members voted in favor.

5. Committee Comments

Ms. Foster talked about the roundabout by the high school and the school zone. The speed is 45 mph where the kids cross the street. It seems too fast and wondered if the school zone could be extended beyond that intersection. Captain Carlson stated that Elwert Road is a Washington County road and not in the City limits. The PD has reached out to Washington County and they are aware of this issue. The Traffic Officer has been reaching out to the county and is working on getting that speed zone changed. Mr. Galati stated that with the county roads, the county has to put in a request to the State Engineer. The City also writes a letter of support. The City of Sherwood has already done this. Elwert Road used to have a 55 mph speed limit, and it has been knocked down to 45. He elaborated on this a bit more and why it is so difficult to get the speeds reduced. His opinion is that the speed limit should be reduced to 35 from Edy Road all the way up to HWY 99. Mr. Bevel asked how long it takes to get a speed changed. Mr. Galati recalled that it takes approximately eight to eleven months to get it through the process.

Captain Carlson told Vice Chair Yandt that she did a great job chairing the meeting that evening. He let Ms. Patterson know that it was great to have her on the committee.

Captain Carlson let all committee members know that due to a new House Bill, the next TSC meeting will be through Zoom. Angie will be sending out the Zoom meeting invites, as per usual. It should be an easy, seamless process.

Chief Hanlon extended his thanks to all of the committee members for volunteering their time to serve on this committee. This is a big deal and really important. He and his family have lived in Sherwood for 27 years and all of his sons went through the Sherwood school system. There wasn't this avenue to express concerns way back when. Livability and traffic has always been probably number one and two in both of the agencies that he's worked for. He really appreciates the committee members taking the time to do what they do. He let them know that he is always available, if they want to reach out.
