1. Call to Order

Vice Chair Yandt called the meeting to order at 6:00 p.m.

2. Roll Call

Committee Members Present: Vice Chair Tiffany Yandt, Tony Bevel, Diane Foster, Dorian Libal, Lisa Patterson (arrived at 6:30) and Mike Smith

Committee Members Absent: Chair Jason Wuertz

City Staff Members Present: Captain Dan O'Loughlin, City Engineer-Bob Galati, and SPD Executive Assistant-Angie Hass

3. Approval of Minutes

Mr. Libal moved that the July meeting minutes be approved as written and Ms. Foster seconded the motion. All present committee members voted in favor.

Resident, Mr. Joseph Perkins, was in attendance requesting to provide a Citizen Comment pertaining to a new traffic safety request the committee was reviewing that evening (#2022-010). In consideration of his time, it was decided to move this on the agenda from item #4.b.iii. to 4.a.

4. Business

a. NEW: 2022-010: Saint Charles Way-Request for "No Parking" Signs (See Exhibit "A".)

Citizen Comment: Joseph Perkins, Resident - Saint Charles Way

Mr. Perkins stated that he likes to be considerate of neighbors and even more so of the neighborhood. He keeps his property clean and well maintained. He keeps the neighborhood post box clean that is on his property, free of moss and dirt. At the request of two female neighbors, he put down ground liner and pebbles so that the neighbors will not have to walk in mud that surrounds the post box. There is an ease way parallel to his home that extends from the street, so when there are kids in school, he regularly cleans the path of debris and weeds, including dog poop.

About the issue of the blind spot, when a vehicle is parked on the street, he stated that years ago, he had given thought to why he should park his van on the street. He observed that some drivers go faster than others and assumed that some were going above the speed limit. He is concerned about the safety of everyone. What is especially worrisome for them, is their daughter that lives with them. She is 28 and has a disability (cerebral palsy and mentally delayed). She needs constant supervision. They are aware that there could be an accident if she wandered off and ran into the street. Mr. Perkins explained that for safety, he parks his van on the street. Together with cars parked on the other side of the street, they create a bottleneck, forcing drivers to slow down and safely navigate the physical barrier. He didn't believe a crosswalk or sign would change some people's driving behavior. He believed the path was made in 1996, the same year that their home was built. They have lived at that address since 2008. He parks his cargo van mostly on the street. He hadn't done any research, but was pretty sure there had never been an accident involving a vehicle or pedestrian since the path was made. If that is true, he believed the history of neighborhood proves it to be safe as it is.

Of the options that the traffic safety committee will be considering, if a "No Parking" zone is imposed, he would request that he be able to use the space in front of his home as a load and unload zone.

After presenting his comment to the committee, Mr. Perkins thanked the committee for listening and excused himself from the meeting.

Captain O'Loughlin had sent the committee a couple videos that he and Officer Pierce had created to help demonstrate the potential issues on Saint Charles Way. As there wasn't a way to share the videos to the whole committee that evening, some committee members pulled the videos up on their phones and shared the view with others. After folks were done, Captain O'Loughlin said that he would talk about the videos, but first introduced Officer Chris Pierce. He stated that Officer Pierce is the Traffic Officer and

would be attending more of the TSC meetings. He explained that other officers also perform that function, but traffic is Officer Pierce's primary function. The committee welcomed Officer Pierce.

In regards to the videos and photos sent to the committee, Captain O'Loughlin explained that the reason he was down on one knee in the video was to give more of a representation of the height of a juvenile that would be coming down the pathway from Archer Glen school property. He added that if they take the van out of the picture and look at the way the bend is in the street, it would be very difficult to see a person come out from the walkway onto the roadway. If there was any vehicle there, it would be difficult to see. He pointed out that there is no sidewalk on the side of the street where the van parks. He stated that the first time he went to the location to observe, he saw a young juvenile in front of the van – but not until he got closer. There definitely is a sight obstruction there. Any car or van would be the same. Mr. Libal asked Captain O'Loughlin if it is a hazard. Captain O'Loughlin said that with a van or a car, it is an issue. He talked about different possible options for making it safer, including "No Parking" signs and getting kids safely to the other side of the street where there is a sidewalk. Another thing they noticed was that the walkway has a downhill slope. If someone is on a bike or skateboard, they could go right into the roadway which might be troublesome. They recognize that there are lots of streets in the City that have twists and turns and that parking is a premium throughout any city street. Mr. Smith stated that he had driven by that day and noticed that there were three vehicles in Mr. Perkins driveway. There was a huge RV, a van and smaller car. If Mr. Perkins continues to park all his vehicles in his driveway, that would be a solution. Captain O'Loughlin stated that from a police department perspective, anyone could park in front of his house.

Mr. Galati stated that there are a couple conditions like this across the City. He shared that in one location, SW Century Drive, there is a mid-block crossing and restricted parking on either side of the crossing zone. Something similar to this set up, might be appropriate on Saint Charles Way. It wouldn't cost a lot to do the striping and signage. Captain O'Loughlin stated that from a police department perspective, he agreed with Mr. Galati, 100%. With this involving a pathway coming from a school, it makes it kind of a unique situation.

In regards to adding a Loading Zone, per Mr. Perkins request, Mr. Galati said that if a "No Parking Zone" is added, it has to be no parking for everybody.

Officer Pierce thought that sounded like a good solution, a mid-block crossing with no parking within 20 feet on either side. Mr. Galati suggested that if the committee members had time, they might want to check out the set up on SW Century.

Mr. Libal asked if they could put up a 15 minute Loading Zone and Mr. Galati explained the challenge of that and how it wouldn't work.

Mr. Smith asked Mr. Galati if having a bollard in the middle of the bike path might help slow the bikers and skateboarders down. Mr. Galati didn't see a benefit to that. They are more trying to prevent motorized traffic from going on the pathway. They don't want to cause a problem for bicyclists. If there have been no reported incidents, then he wouldn't worry about installing bollards at this time.

Ms. Patterson arrived at this point in the meeting: 6:30.

Ms. Foster liked the idea of having a ped crossing there. She had walked that area many times, but didn't realize there was a path there by Archer Glen. Captain O'Loughlin asked Mr. Galati if the pathway is owned by the City or School District. Mr. Galati said the City probably owned that pathway. He believed it was done when the subdivision went in.

Captain O'Loughlin added that there wasn't any indication of crash data history for this area.

Mr. Smith asked if the speed limit is currently 25 mph. He was told that it is a residential neighborhood and is zoned for 25 mph.

Ms. Patterson asked if they would need to add in truncated domes when they add in the striping. Mr. Galati said no and explained why.

Ms. Patterson made a motion that the committee vote to put in a recommendation to the City Manager that they sign and stripe the pedestrian mid-block crossing. Mr. Libal seconded the motion and all present committee members voted in favor.

b. Review of TSC Process Manual & Menu of Traffic Safety Options (See Exhibit "B".) As a refresher for committee members and, perhaps a first time look for the new members, Captain O'Loughlin referred everyone to page one for review of examples of issues that the committee can and cannot handle.

Mr. Galati helped with clarification on the things that the committee would refer more to a Capital Improvement Project (CIP). When a recommendation is submitted to the City Manager and his boss, the Public Works Director, sets aside funds to perform a Transportation Systems Plan (TSP) update. This update can then incorporate all these different issues onto one list.

Generally speaking, issues like Sunset and HWY 99, wouldn't be handled by the TSC. Those types of projects get handled through the TSP. This committee shouldn't be working on projects of that size. They can support the process of how it's handled by the community. Pedestrian striping and things like that are great. Citizen requests are not ignored but redirected. Mr. Galati's department, Public Works and the City Manager's Office have a long laundry list of complaints. They would love it if the TSC could just go ahead and address some of those issues. If the City receives a direct safety issue request, they will make it a priority. The long term, larger projects are put on the TSP. That is the methodology and the tool they need to use and support.

Mr. Smith talked about past issues reviewed by the committee, to include the Langer Farms Pkwy roundabout. Mr. Galati stated that was looked at by City staff because there had been a recent incident at that location. It was relooked at and reviewed by the engineering company they hired, who determined that it was designed correctly. Mr. Galati added that there is no transportation system that is 100% safe.

Captain O'Loughlin asked Mr. Galati if the TSC was dealing with a traffic circle that did require a redesign, that would not be something to be put before the TSC to try and resolve, correct? Mr. Galati said that the TSC would be recommending support for having a review done by the City as dictated by the City Manager through the TSP. The TSP would be performed and be able to identify those conditions and decide whether it is deficit or not, which is what they're supposed to do. Corrective measures would be then identified through the TSP. Mr. Smith asked about the recommendation that the committee had made at the time to change the roundabout from two lanes to one lane. He wondered if it had then been determined that wasn't the way to go. Mr. Galati explained why it was decided to leave the roundabout as is and stated that it would create another issue if converted to one lane.

c. Traffic Safety Requests

Please refer to the Tracking Sheets (Exhibit "C") for more information on the requests discussed at this meeting.

i. 2022-002: Parking in Old Town / Review document provided by Bob Galati (See Exhibit "D".)

The discussion for this request begins at the 47 minute mark of the YouTube video.

The committee reviewed the document showing how the parking was laid out for the Old Town Streetscapes Phase I and II projects, that Mr. Galati had sent out (see Exhibit D). Mr. Galati stated that the spacing is set up correctly. The issue is how to stop people from ignoring those rolling curb lines and parking in the colored brick areas. On phase II that isn't going to happen when they change the curb line to a 90 degree angle. People will know when they hit the end of the curb. Phase II improvements were painted and striped. He wasn't sure what else could be done. He suggested possibly repainting with a different color.

Mr. Smith wondered if it is legal to park up against a big concrete post. He was told it is not. Mr. Galati described some recent parking issues that he had observed. Striping has been changed on phase I, but he sees cars parking outside of those zones.

Ms. Foster asked if that area has been patrolled, ticketed, or warnings given. The committee had talked about an education piece in previous meetings. Captain O'Loughlin said that the area can be patrolled and some would be educated, but a lot of people wouldn't be hit on enough for education. Ms. Foster stated that the other piece, previously discussed, was putting out a social media post by the PD. A lot of people she'd talked to didn't even know parking is not allowed close to a stop sign.

Captain O'Loughlin asked about the previous discussions regarding crosswalks in old town as well and Mr. Galati explained that there is a difference between a set back from the crosswalk and a setback from the intersection at the curb line. Captain O'Loughlin stated that at the July meeting, there had been suggestions to install bike racks, planter boxes, etc. for barriers. Mr. Galati explained that there are technical requirements for planter boxes, etc. Different possible options were discussed. Mr. Galati stated that whatever the committee recommends has to be backed up by the PD stating that this is an issue. Captain O'Loughlin added that from the PD's perspective, it's a risk factor in regards to it being in non-compliance with the crosswalk, and something that needs a recommendation in regards to a solution. He agreed with Mr. Galati that painting can be something difficult to deal with. So, from the police perspective, they ask that the committee think of additional recommendations. Mr. Galati stated that with the recommendation, the PD will most likely be asked what the incident rate is, such as the number of accidents, pedestrian injuries, etc.

Mr. Libal thought that a pretty simple solution would be to put up signage, such as "2 Hour Parking" with an arrow and "No Parking" with an arrow the other direction. Mr. Galati said that the concept is simple, but they have those signs all around town and people still park in those spots. Captain O'Loughlin said that 90% of the time, a sign works, but explained how this situation is a little different. They would need to change that specific parking stall so it doesn't look like a parking spot. Mr. Libal wondered about painting the curb red. Mr. Smith asked how many parking spaces they were talking about and Mr. Galati replied that there were 12. Ms. Foster stated this is why this particular request keeps going around and around and elaborated a bit more. She felt that maybe at this point, it should be a City review issue. Captain O'Loughlin suggested that this committee provide some different options and come up with a proposal and then take to the City. Mr. Bevel asked how much money a part time meter reader would be. He was told it would way more than planter boxes. Discussion ensued regarding the different possible options.

Mr. Smith made a motion to make a recommendation to the City Manager that the City reviews each affected parking area as appropriate to add physical barriers (planter boxes, bike racks or wheel stops), curb painting and/or signage where parking is not allowed. Ms. Patterson seconded the motion and all present committee members voted in favor. As there was nothing further that the committee could do, request #2022-002 was closed with this recommendation.

ii. 2022-004.1 & 2022-004.2: Intersection @ Walmart & Langer Farms Pkwy / Pedestrian Crossing

The discussion for this request begins at the 1 hour, 20 minute mark of the YouTube video. Vice Chair Yandt stated that because Chair Wuertz wasn't in attendance that evening, she didn't believe the committee would be able to discuss this request, as they would need him to share his recommendation.

Mr. Galati stated that City staff is currently working on white papers to present to the City Manager and Public Works Director, already, about this particular request. They have an idea and he felt that it is going to work fine. They are looking at removing stop bars at the ped crossing. He doesn't necessarily agree with the fact that based on the signalization and striping, that it meets the standards without the stop bars. In conjunction with that, they're probably going to prevent the vehicle crossing from Target to Walmart. Drivers won't be able to make that left hand turn either way that will reduce that left turn movement from the parking lot onto Langer Farms Parkway. If the left turn is eliminated, there's no more possibility of a T-bone crash. Officer Pierce asked about the other exit from Target. Mr. Galati stated that his idea was to make the exit by Red Robin a right hand turn only. They will add candle sticks to aid. Mr. Galati was confident that they will receive complaints from drivers and business owners, alike.

Captain O'Loughlin said that when the PD did their analysis of that whole roadway, the few accidents that had occurred, had really nothing to do with what they're talking about making changes to. The data doesn't show there are a lot of accidents there. They had recently conducted a very rough data collection of watching that intersection to see what the behaviors were over a very short period of time. During that short period of time, they watched 30 cars successfully navigate that intersection going into Walmart and Target. The drivers appeared to know what they were doing and there wasn't an issue. In that same time period, they had 12 cars that stopped or came to a close stop at the "non" stop, stop signs at the crosswalk and the drivers gave the impression of uncertainty. He felt that made for a hazard situation. A discussion ensued.

Captain O'Loughlin asked the TSC if they'd like to make a recommendation in regards to doing what they were just discussing, which is a phased approach. Mr. Galati stated that they are already doing a white paper to the City Manager, which incorporates what he had just mentioned. He suggested that they recommend that the City staff continue trying to find a solution and that they support that the City staff will come up with a solution. Mr. Smith wondered if Mr. Galati would be able to show the TSC the white paper that he and his staff had put together. As this would be Mr. Galati's last meeting, he wouldn't be able to do that. He stated that he had been working with co-worker, Jason Waters, on this. Mr. Galati added that if there is no money in the maintenance funds for this cycle, there is a possibility that they will come up with funds. The City manager wants something to be done. There was a discussion to decide whether or not to wait for Chair Wuertz to present his recommendations before making their decision. Mr. Galati shared how the current set up was decided upon and added that there are always anomalies. The committee decided to wait for Chair Wuertz before closing this request out.

5. Committee Comments

Ms. Patterson asked Mr. Galati if his replacement had been found yet, as his retirement date was quickly approaching. Mr. Galati stated that the job opening was posted and that applicants had gone through a first round of discussions and interviews. Two applicants moved to the finals, but final interviews had not yet occurred. The Public Works Director will make the decision on who will be the interim person to represent Mr. Galati's position at these meetings, until his replacement has been hired. Mr. Bevel asked how many applications had been received and Mr. Galati replied that he believed they had received seven applications, total.

Ms. Patterson shared information regarding a community enhancement grant that she had learned about and wondered if the TSC would be interested in being part of it. This particular one had already closed, however. The grant includes community art projects for crosswalks, pavement markings, community gathering spaces, etc. She thought it might be fun for the TSC to do something like this, but didn't know if it was something that the TSC could help structure, create, or provide guidance on. She asked Mr. Galati if he thought this would be okay for the TSC to do and/or if there would be a permit process that they'd have to go through. He talked about art he'd seen in other places. He had read about an analysis that had been conducted and the effectiveness at night is not good for some of those 3D crosswalk paintings. He did feel this could be appropriate if done in pedestrian corridors. Ms. Patterson stated she was thinking of this for residential and local streets. Mr. Galati stated anything that is in the right of way that is not maintained, he doesn't feel appropriate and could detract the driver from paying attention to being safe and positively maintaining focus. He would support it in a safe place, like maybe on the ped bridge. As long as it doesn't impede on safety, it might be okay. Captain O'Loughlin didn't necessarily think it was a bad idea. If a grant is specific to the arts, and this wouldn't affect safety, it will have a lot of backing and he would be 100% for it, if she can find a grant.

Ms. Patterson let the committee members know that a Grand Opening was scheduled for that Saturday (9/24) for the new Cedar Creek Trail. Mr. Bevel asked how long the trail is and Mr. Galati replied that it is about a mile long.
