Attached is a receipt for \$10.00 research/labor expended.

There were a number of potential places I thought something like this could be found in our holdings. Unfortunately, I struck out on all of them:

- 1. Our official documents electronic database index (a long shot as most of the entries in this are fare more recent than what you're interested in, but it was also a very quick search time-wise);
- 2. Our official documents card file index (what I thought to be the most likely possibility; unfortunately, the earliest official document we have relating to Sherwood was from 1912);
- 3. The records from the Secretary of State's office in our holdings, particularly those of the executive office and the elections division unfortunately I did not come up with anything related in those records at least nothing that struck me as being even remotely likely to contain this information; and
- 4. Our electronic records management system (my colleague researched old city incorporations awhile back for the Blue Book and put documentation he found into this system, but there was nothing relating to Sherwood).

Of course I've been doing this long enough to know that with an Archives like this one, you can never truly say never, and there's a possibility some sort of record could be squirreled away somewhere. But I can say that anything I thought remotely likely turned up nothing.

You might consider contacting the State of Oregon Law Library, primarily because I recall back in the day they had old city charters; whether that document would be helfpul to you with this question, I can't say for sure. City charters are not generally something we get here. So you might consider that.
