SHERWOOD CITY COUNCIL 02-03 BUDGET COMMITTEE MEETING #1 APRIL 17, 2002 HITE HOUSE

- 1. The meeting was called to order at 6:08 p.m.
- 2. Roll Call: Council members present*: Mayor Mark Cottle, Council President Keith Mays, and Councilors Sterling Fox, Angela Weeks, Dave Heironimus, and Dennis Durrell. Absent from Council: Thomas Claus. Finance Committee members present*: Mitch Wash, Justin Denton, and Steve Munsterman. Absent from the Finance Committee: Mike Schoen, Paul Stecher and Dave Luman. Present for staff: City Mgr Ross Schultz, City Recorder Chris Wiley, Public Works & Eng. Depts. Dir. Terry Keyes, Human Resources Analyst Amanda Klock, Finance Director Chris Robuck, Systems Administrator Brad Crawford who was excused from the meeting after he completed videotaping the public comments portion of the meeting, Police Chief Bill Middleton, and Public Works Operations Manager Craig Sheldon.
- *When the Council, composed of elected representatives, and the Finance Committee, composed of appointed representatives, sit together, they form the Budget Committee.
- 3. Mr. Wash was elected to serve as chair for the 02/03 Budget Committee. Mr. Munsterman was elected to the Vice Chair.
- 4. Public Comments:
- A. Mr. John Harshbarger, 17059 SW Lynnly Way, said he was testifying on behalf of the Parks Advisory Board. Mr. Harshbarger said he thinks previous budgets have been inadequate to support parks maintenance requirements.
- (1) Mayor Cottle asked if the Parks Advisory Board had ever discussed fees for park maintenance. This year the City implemented a portion of that plan by charging fees for players who use the fields. Could the Parks Board make a recommendation to the City Council about whether or not there should be a fee or a levy to support parks maintenance? The Parks Board could take community comments to find out what would be more acceptable, a fee or an operating levy and develop a recommendation as to how much money would be needed and then Council could proceed once there is a recommendation.

- (2) Both Mr. Harshbarger and Mr. Dan King, another member of the Parks Board who was also present, said they were agreeable to having the Parks Board study alternatives for financing parks maintenance and bringing their findings to the Council. Mr. Harshbarger said the Parks Board supports what's in the budget although in their opinion that amount of money is the absolute minimum. If the City can't support maintenance for the parks that the City has now then there shouldn't be any future park development or Sherwood will have a whole lot of parks that aren't being properly maintained. Mr. Harshbarger submitted his written statement for the record and it is shown as **Attachment 1** to these minutes.
- B. Mr. Daniel King, 21527 SW Roellich Ave, and also a member of the Parks Advisory Board said there is a need to develop standards for maintaining Sherwood parks. The Parks Advisory Board is glad to take on the responsibility to look at funding options for parks maintenance. He looked at the budget. Some of it is difficult to follow. One observation, although he wanted to say he wasn't signaling out any specific department but Multnomah County where he works has only two police dogs and Sherwood, with a much smaller population, also has two police dogs.
- 5. There being no one else present who wanted to testify, the Public Comment portion of the meeting was closed. There will be one more public comment session, which has been noticed, when the Committee meets to approve the Budget.
- 6. The City Manager presented a Power Point presentation which is shown as **Attachment 2** to these minutes.
- 7. Mayor Cottle said the City needs to start looking at ways to increase revenue. The mayor, who is a local business owner himself, said perhaps the cost for a business license should be increased. Presently the City makes about \$75,000 a year on business licenses. What would it take to raise it to \$100,000? The mayor asked staff to see what the City would bring in if the cost of a business license was increased from \$75 to \$100 a year. Councilor Heironimus concurred saying he would like to see a review of all the revenue sources for the City to see what can possibly be increased. Mr. Wash said the Finance Committee would be reviewing the fee schedule soon. Mr. Schultz said the fee schedule review would take place in the August/September timeframe.

- 8. Ms. Robuck distributed two handouts to the Budget Committee members. The first handout, (presented with these minutes as **Attachment 3**) titled "Cuts That Have Been Made," shows the Budget Committee the items staff already cut from their initial budget plan before bringing the budget forward that's presently before the Committee. The second handout (**Attachment 4**), titled "General Fund Contingency", lists changes that could be considered and which would bring the City up to a healthy contingency fund balance. The rule of thumb for determining a reasonable contingency balance is that it should be 10% of anticipated revenue. Anything less than 5% of revenue should be reviewed closely. Ms. Robuck pointed out that the City typically comes in under Budget every year. Both Mr. Schultz and Ms. Robuck said they would be comfortable with a contingency fund for FY 02-03 in the \$300,000 to \$500,000 range.
- 9. Councilor Heironimus asked Ms. Robuck if she could look at other cities' revenue sources so the Budget Committee could see if Sherwood is missing something. Mr. Schultz said he'd already done some of that and had asked for information from the City of Tualatin on how they impose road fees. A road fee could bring in more than enough revenue to take care of Sherwood's streets.
- 10. The next Budget Committee meeting is scheduled for April 24, 2002, from 6 to 8 p.m. at the Hite house. There will be dinner for the Budget Committee members and critical staff. Items on the agenda for the next meeting are: Capital Projects, Public Works, and Urban Renewal Agency.
- 11. The Budget Committee meeting adjourned around 7:30 p.m. and a brief Urban Renewal Agency (URA) meeting immediately followed. All those present for the Budget Meeting remained for the URA meeting.
- 12. Mr. Schultz said presently the URA budget is in transition. Staff will be asking for a lot of flexibility in the URA budget because the Sherwood Urban Renewal Policy Advisory Committee (SURPAC) won't have a lot of the forecasting done before this budget planning season ends. There is no information on revenue or projects yet.
- 13. The Committee recessed until April 24, 2002 at 6 p.m.

Parks and Recreation Construction and Maintenance Budget for FY 02-03

We have worked closely with City Staff in the development of the long-range construction program and the Public Works - Parks Maintenance Budget for the City's FY 02-03 budget. We believe the budget presented represents the goals of the City and the needs and desires of all of our citizens.

It is the expressed goal of the City to make our parks and recreation facilities a priority. This includes constructing and completing facilities to meet the expanding needs of our residents as well as maintaining these facilities in a safe, useable, and attractive condition.

The 5 year construction program represents a blend of completing master site plans at three of our larger parks, completes Snyder Park and reconstructs two other parks, supports sport field improvements and initiates development of a trails and bike-ways linking recreation and commercial destinations within the city.

We believe prior years budgets have been insufficient to maintain our parks and recreation facilities at an adequate level. This budget request represents increases in maintenance personnel and funding to bring the maintenance level to a minimum acceptable level and support the new facilities being constructed.

We also wish to support the open-space management program. This very necessary program has the potential to partner with outside groups thus leveraging limited resources.

In closing, we believe this budget request supports the expressed goals of making parks and recreation facilities a priority. It presents a balanced construction program and a maintenance funding to adequately support the facilities within the city.

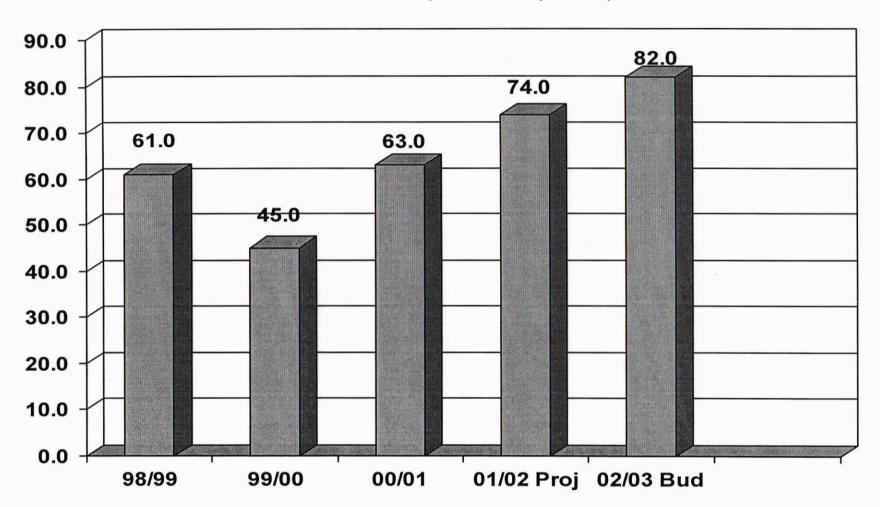

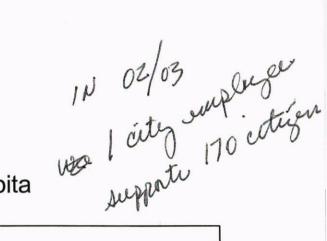

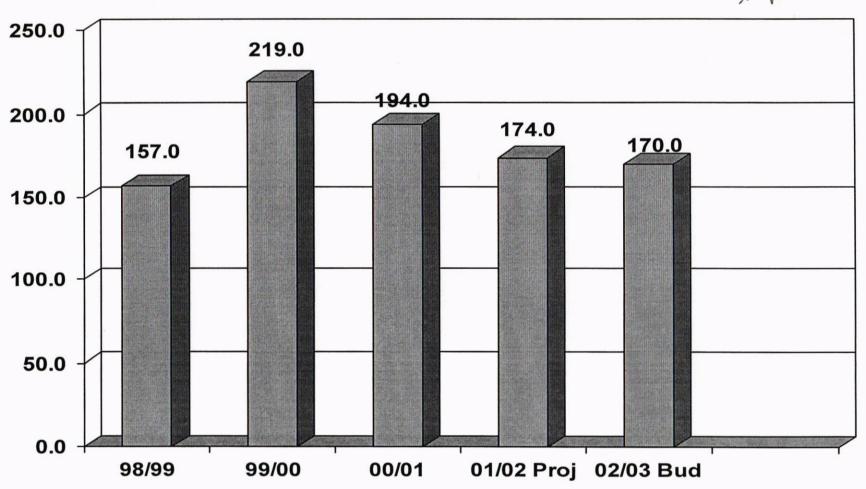
Full Time Equivalents (FTE's)



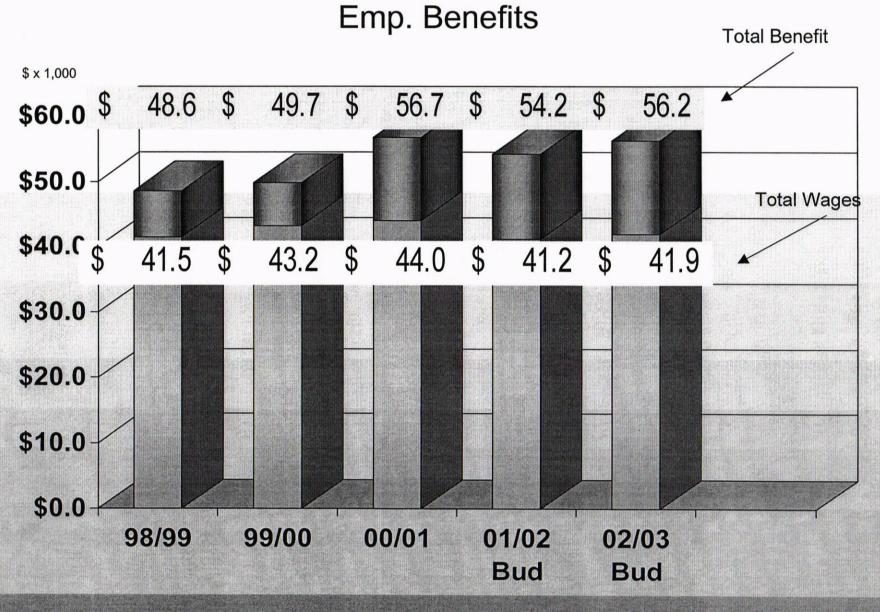

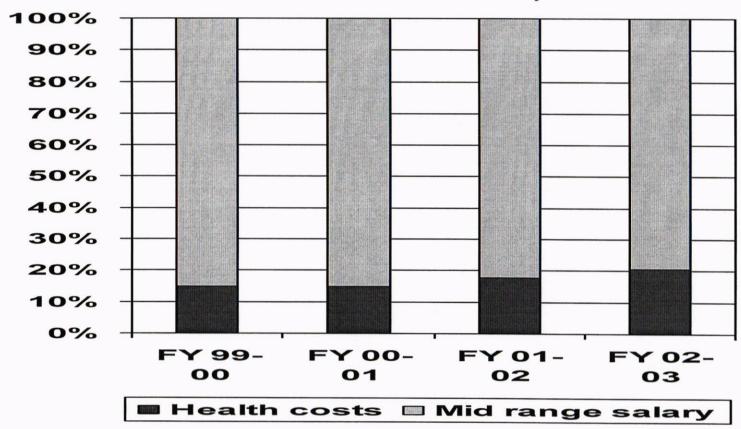

Health Costs vs. Salary



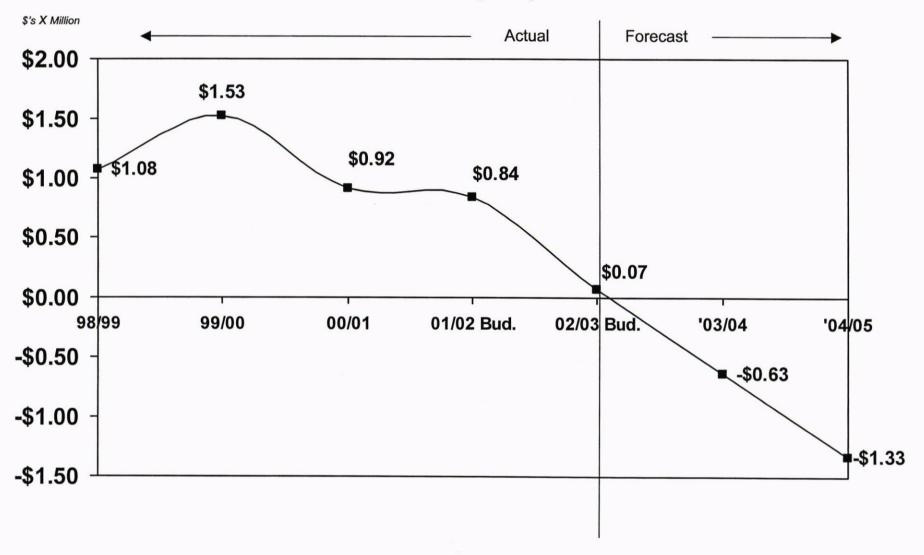

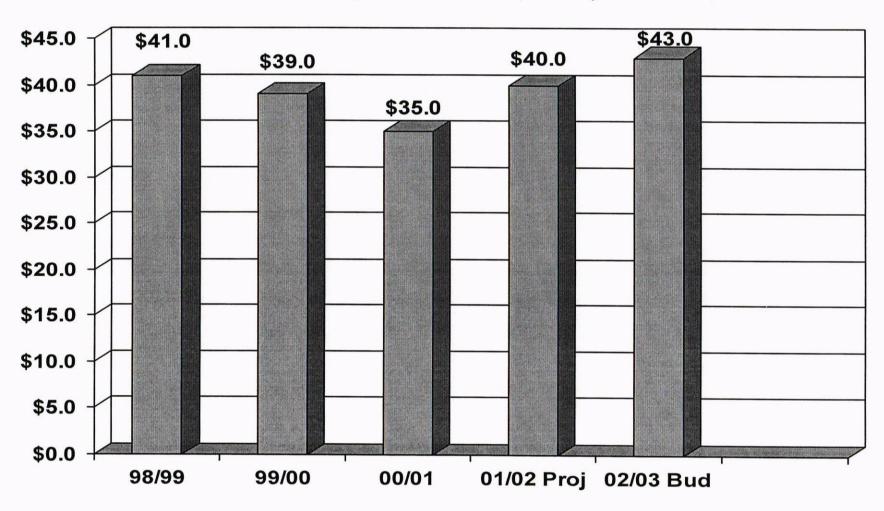

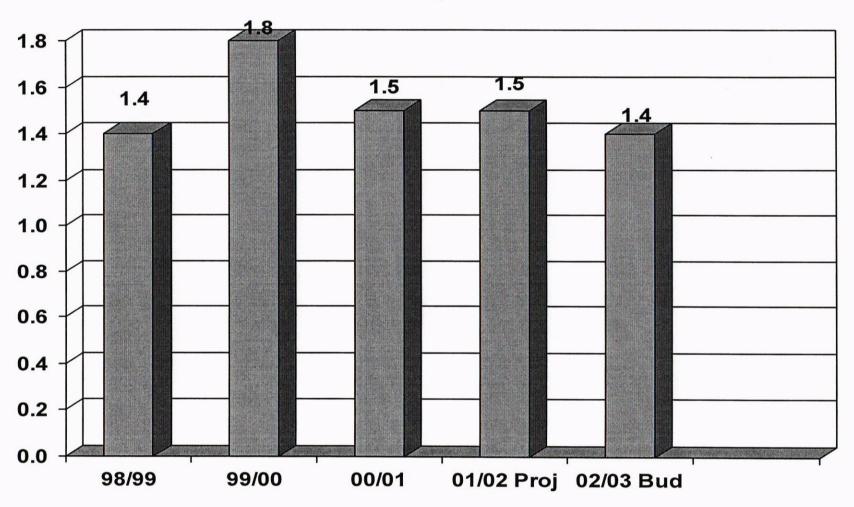

Library Expenditures per Capita



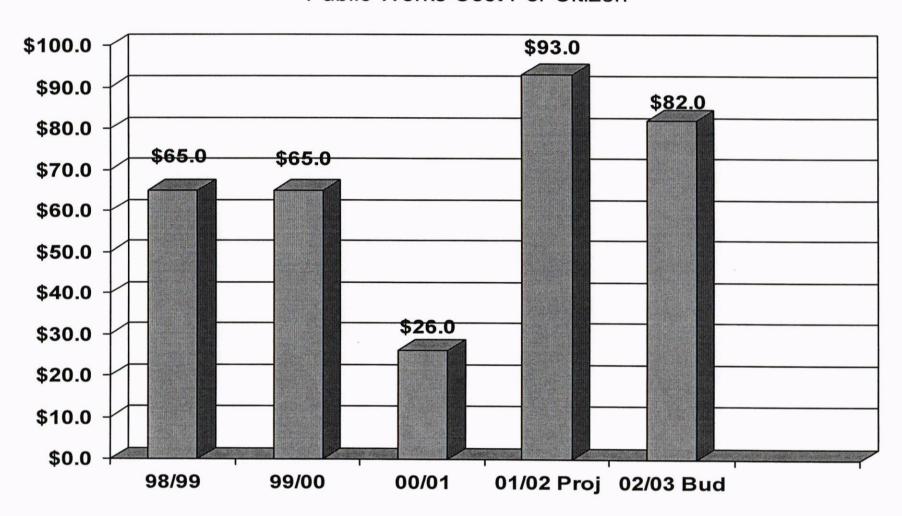

Police Per 1,000 Citizens



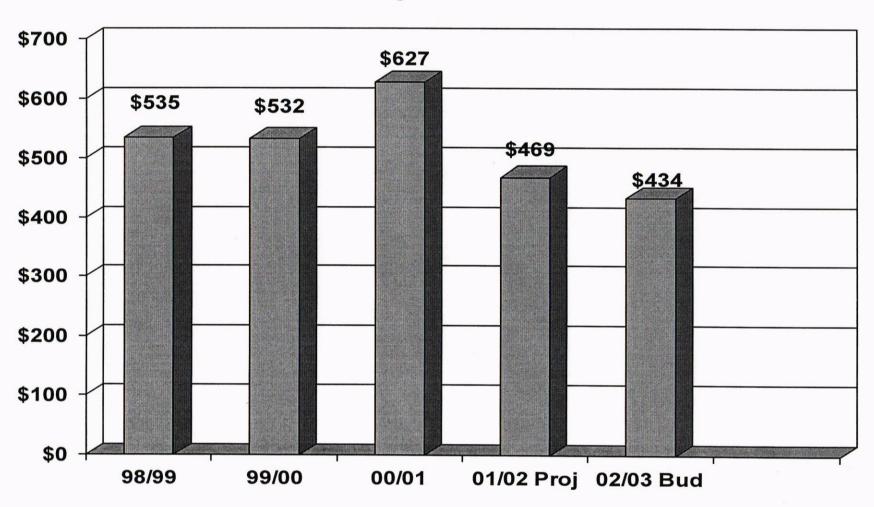

Public Works Cost Per Citizen



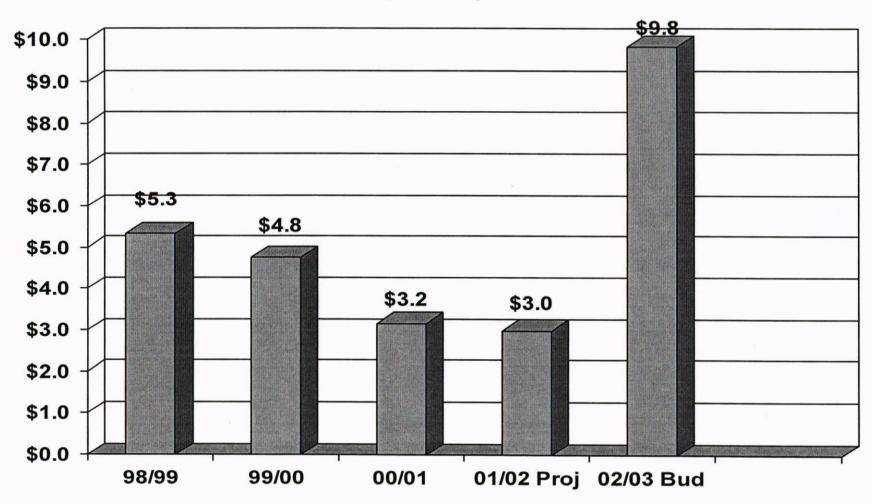

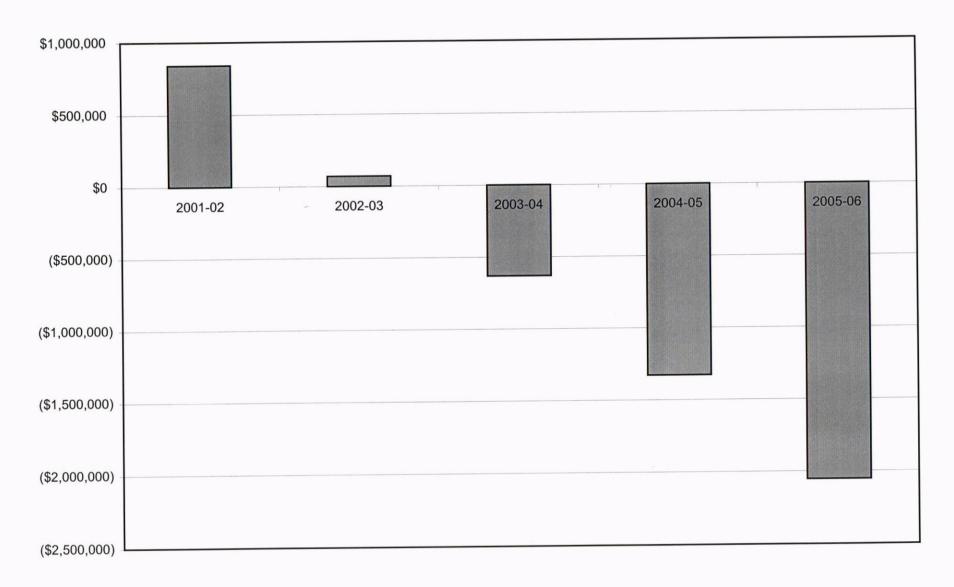

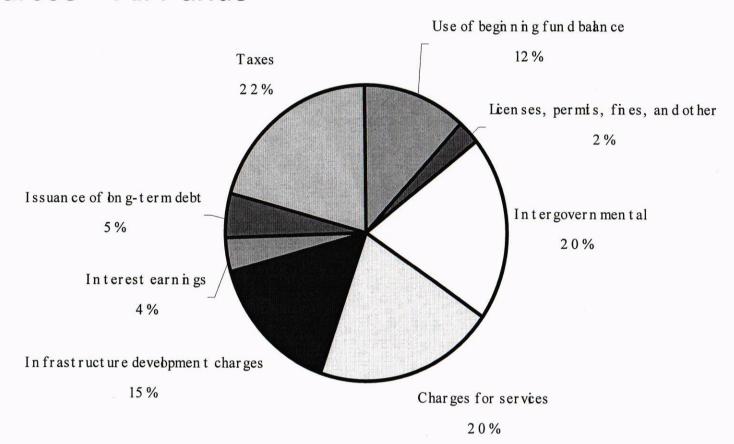

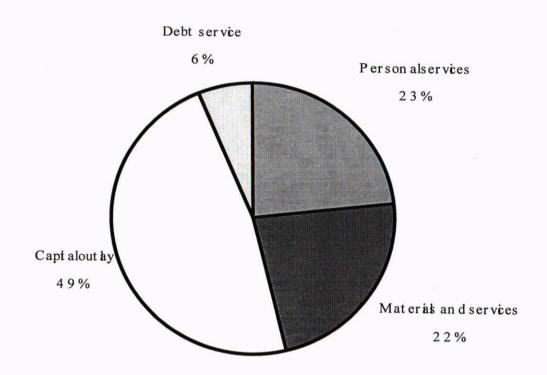
Projected General Fund Balance



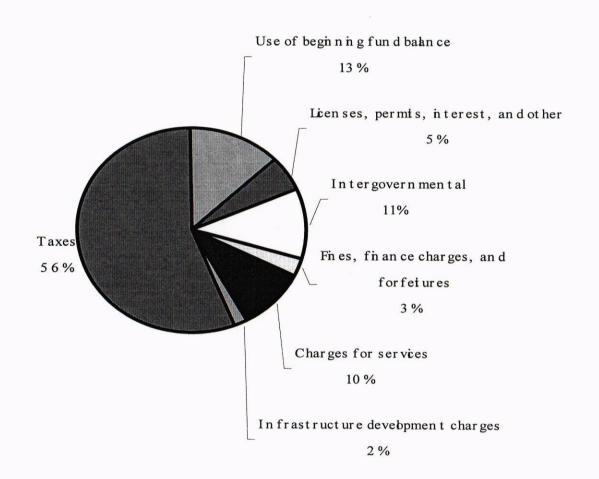

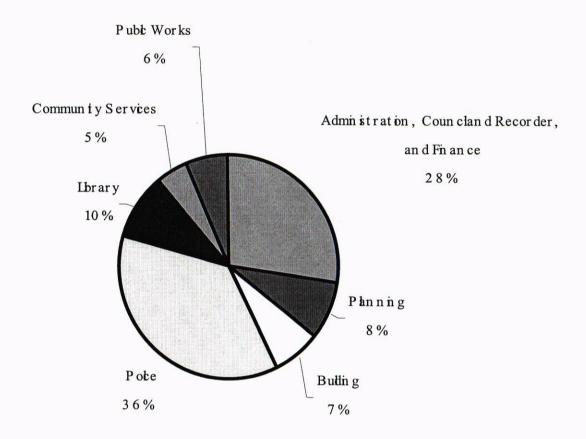
Uses - All Funds
