Caption: Rules for the implementation of OHCS' ReOregon Disaster Recovery Programs

Summary: These rules will allow OHCS' Disaster Recovery and Resilience Division to implement disaster recovery programs in response to the presidentially-declared 2020 Wildfires and Straight-line Winds and funded by the HUD Community Development Block Grant – Disaster Recovery funding award of \$422,286,000. Funding was allocated through publication in the Federal Register, Vol. 87, No. 23, February 3, 2022 (87 FR 6364). Program implementation is outlined the ReOregon Action Plan, Version 2, originally dated September 30, 2022.
