Rules Advisory Committee: OHCS conducted engagement with impacted partners through a series of email and survey questions to verify the filing fiscal and economic impact statements. The proposed impact statements were agreed upon by partners and impacted communities' members and there was no additions or comments to add into the Notice of Proposed Rulemaking.

Rules Public Hearing: The rulemaking hearing on the proposed rules was convened on February 19, 2025. People were asked to sign the attendance form and indicate if they wished to comment on the proposed rules. They were informed of the procedures for taking comments. They also were told that the hearing was being recorded.
