Rules Advisory Committee: OHCS conducted engagement with impacted partners through a series of email and survey questions to verify the filing fiscal and economic impact statements. The proposed impact statements were agreed upon by partners and impacted communities members and there was no additions or comments to add into the Notice of Proposed Rulemaking.

The rulemaking hearing on the proposed rules was convened on January 22, 2025. People were asked to sign the attendance form and indicate if they wished to comment on the proposed rules. They were informed of the procedures for taking comments. They also were told that the hearing was being recorded. Before receiving comment, Jaci Davis briefly summarized the proposed rules. There was also an informal opportunity for people to raise questions about the proposed rules, and Scott Shaw was available to answer questions. Twenty-one people attended. The rules change to the FLEX Lending Program include:

- Explain NextStep and additions into rule guidance The NextStep is the rebranding of the current Flex Lending Program. The loan program itself will have 2 changes, a new program name and adjusted the DPA 2nd mtg lien (for borrowers whose AMI is less than 80%) to be a silent second which replaces the existing forgivable DPA 2nd mtg. All other program parameters will remain the same.
- Explain FirstHome and the changes from the Bond Residential Loan The FirstHome product is replacing the existing Oregon Bond Residential loan program. This change will align with the NextStep loan program in servicing, compliance and loan delivery. This allows the loans to be securitized into mortgage backed securities. This will triple the number of lenders that can offer the product which will allow us to reach more Oregonians. We have also included the ability to pair our existing DPA with the FirstHome loan product, which was not available on the previous Oregon Bond Residential Loan program. The DPA is in the form of a Silent or repayable second mortgage.
- These changes are the first steps to creating a stable platform to help more
 Oregonian's achieve homeownership. As well as opportunities for more lending products with more options and offer below-market interest rates.

OHCS invites comments about these proposed rules and whether other options should be considered for achieving the rules' goals while reducing potential negative impacts that may derive from the rules as currently proposed.
