

#### **RESOLUTION 2024-080**

### APPROVING THE CITY RECORDER'S CANVASSING OF THE WASHINGTON COUNTY ELECTION RETURNS OF THE NOVEMBER 5, 2024 GENERAL ELECTION AND DIRECTING THE CITY RECORDER TO ENTER THE RESULTS INTO THE RECORD
